Jobs at prestigious international law firms like *Herbert Smith Freehills, Allen &Overy* and *Linklaters LLP* have been secured by our meritorious and assiduous scholars while others have gone on to work towards partnerships in leading national law firms. 22 students of NLUJ have won the coveted Aditya Birla scholarship till date which entitles them to receive scholarship during their entire time span on the campus and also benefit from exposure to the diverse pool of talent available within the Aditya Birla Group.

Regular academic events and lecture series hosted at the University are curtain raisers to diverse spheres of thought and concern in the contemporaneous realm of Law and help students analyze law in action. The organizational endeavor, along with spirited participation, develop the co-curricular exposure of students and serves them in good stead in the years ahead. Competition Commission Officials from ITEC Partnering Countries ocllaboration with Competition Commission of India; organization of the *Fifteenth Convocation* of the University in the august presence of Justice PankalMithal, Hon'ble Chief Justice of High Court of Rajasthan and the then Chancellor of National Law University Jodhpur; lectures were delivered by Hon'ble Mr. Justice Michael Wilson, Judge, Supreme Court of Hawaii; Hon'ble Mr. Justice Matthew F. After a hiatus of two years, all the organizational fixtures in the calendar year of the University were organized with grandiloquence and marvellous precision in the offline mode including the fourth edition of the *NLUJ Parliamentary Debate*; the *first IP Law & Practice Conclave*; the *VII CARTAL Conference on International Arbitration* in collaboration with Linklaters LL.P. making it the first event at an Indian law school in collaboration with Linklaters; the *Fourteenth NLU Antitrust Law Moot Court* Competition under the patronage of the esteemed Competition Commission of India, and in collaboration with Cyril AmarchandMangaldas; the VI edition of NH-65, the Cultural and Academic fest of the University and the *Allen & Overy-NLU Jodhpur International Deal Negotiation Competition*, 2023 which was organized by the Alternative Dispute Resolution Committee.

Special Training sessions for heterogenous legal groups were undertaken with aplomb and included an Online Certificate Course on *Evolving Paradigms of Insolvency and Bankruptcy Code, 2016*; *Special Training Programme in Clinical Legal Education* under the aegis of ITEC was imparted to participants from 20 countries; training for 29 delegates and 03 higher officials from the Office of the Attorney General, Nepal in the area of *Constitutional Law, Criminal Law, Cyber Law and Forensic Science* was conducted and the prestigious Herbert Smith Freehill International Lecture Programme-Oxford International Lecture Programme, 2023 was organized by the RICC. Besides academic and co-curricular events, the students also display zest and fervour in marking important national and cultural occasions through organizing debates, poetry sessions, commemorations and diverse other mediums.

Aligning with the intellectual feast on offer is the invigorating natural environs of the University, which is a microcosm of aesthetic perfection and self-sufficiency. State of the art facilities for teaching, learning, mooting, administration, sports, cultural and a wide variety of curricular, co-curricular and extra-curricular activities are available amidst a panoramic environment. Course Structure

The University adheres to a customized and comprehensive semester system with each academic year comprising of two semesters, with 6 subjects (streamlined and vetted by the best experts in the sphere) prescribed for study in each semester. Specialized Honors courses are offered in IV and V year in the realm of Corporate Law, Trade and Investment Law, Criminal Law, Intellectual Property Law and Constitutional Law. Besides Honors courses, several specialized optional courses like Health Law, Media Law, Sports Law, Entertainment Law, Refugee Law, Interface between Law and Jurisprudence etc. are offered as per requirement and availability of expertise. Seminar courses are completed by the students and provide the much requisite super specialization in the students' avowed field of study.

One year LL.M Program in Corporate Laws and IPR Laws

NLUJ offers One-Year LL.M degree programme in 2 specialized branches of Law namely Corporate Laws and IPR Laws. The LL.M programme aims at disseminating a wider knowledge of contemporary developments in and applicability of laws in specialized scenarios and also encourages the post-graduate students to identify and carve out *au courant* approaches to the study of law.

Course Structure

The LL.M. programme is based on semester system with general and specialized courses offered in each semester. The second semester constitutes Dissertation writing which sees its initiation in the first semester itself and helps the student build the citadel of his/her own specialised learning. The programme seeks to build legal scholarship for the future in diverse arenas of law.
