The National Law University Odisha (NLUO) has made a mark for itself in the field of legal education. It was established by Act 4 of 2008 and started its academic activities in 2009. In a span of fourteen years, the University has made a name for itself by earning laurels with excellent performance of its students in various moot courts, literary debating competitions & other co-curricular activities. Our faculty research output has always been of a very high standard. Faculty publications in several top-tier international publications bespeak their subject expertise and scholarship. The student community's engagement with co-curricular activities has yielded remarkable results, including consistent high performance in moot court competitions and active participation in prestigious national and international conferences and seminars. Our rigorous academic discipline, coupled with a friendly learning environment, provides a platform for the students to realize their true potential and develop in their fields of interest and passion.



The University has received recognition from the University Grants Commission (UGC) under Section 12(b) of the UGC Act 1956 and has been receiving grants under the 12th Plan. The University's degrees are duly recognized by the Bar Council of India. It is also an associate member of the UGC-INFLIBNET, and a participant in the National Knowledge Network under the Ministry of Information Technology and Communication, Government of India. National Law University Odisha is ISO 9001:2015 certified and NAAC accredited. National Law University Odisha, Cuttack (NLU Odisha) has witnessed a significant increase in its position on the annual rankings over the last year. As per the annual India Today Report on Best Law Colleges in India, National Law University Odisha was ranked 8th amongst various law colleges and universities across India. As per the National Institutional Ranking Framework, NLUO was ranked at 30 amongst various established universities across India. NLUO has its own campus spread over 50 acres near Naraj at the western extreme of the historical city of Cuttack. The area is known for its scenic beauty.

Why NLUO?

- 1. NLUO provides a platform for a multi-dimensional learning experience that integrates rigorous academic, applied, practical, and cross-disciplinary perspectives to ensure a deep understanding of law in all its contexts.
- 2. We invest in quality legal research and promote an environment that allows intellectual interaction. Our law school is an incubator for nurturing scholarship and innovative ideas and inculcating analytical and critical thinking in the classroom, enriching our students' understanding of law.
- 3. NLU Odisha students are trained by a group of experienced, dynamic, young, and most significantly committed teachers. The teachers at NLUO are mostly alumni of the leading National Law Universities in India and reputed law schools abroad. They come from diverse backgrounds, having served in the office of the Chief Justice of India, practiced in law at the Bar, served in civil society organisations, served in the Indian



Police Service, and have headed various reputed educational institutions in the past. Our faculty is our pride, and we are committed to investing in the scholarship of our faculty so that you get the best in the country.

- 4. We provide state-of-the-art infrastructure like a fully equipped library, 24 x 7 Wi-Fi enabled campus, audiovisual enabled classrooms and moot court hall, Seminar-cum-Convention Hall, Amphitheatre, Conference Hall, Gymnasium, Sports Complex, Cricket & Football Ground, Hostel & Mess facilities, etc. to facilitate a smooth and enjoyable learning process.
- 5. To fulfill our social commitment, we organize legal aid camps in the villages across the State of Odisha in collaboration with the United Nations Development Program, the High Court of Orissa, and the District Judiciary. These programs are organized, and coordinated entirely by the student body under the supervision of law professors. This enables the students to learn the application of law in society and connect it with the principles of law taught in the classroom.
- 6. To multiply the effect of legal scholarship, we frequently organize lecture series/ seminars/ conferences/ workshops on diverse aspects of law and allied subjects by inviting scholars, practitioners, lawyers, judges, and members of the media who share their critical perspectives and experiences in the fields of law, politics, judiciary, economic affairs, international affairs, history, and culture. This provides a platform for open dialogue between scholars, faculty, and students and generates a healthy environment of cross-sectoral learning.
- 7. NLUO provides an excellent opportunity for students to hone their mooting skills, which include drafting memoranda and presenting arguments. Students are also well supported to travel nationally and internationally to represent the university in prestigious moot court competitions. The University has its own state-of-art moot courtroom facility.
- 8. To keep a close check on our quality standards, we conduct periodic revisions of academic curriculum, course syllabus, teaching pedagogy, and learning skills to meet the changing needs of legal education based on the student feedback, peer review process, and professional and industrial inputs.



Research and Innovations

Research and innovation are the bedrock of any progressive institution. NLUO has adopted this principle since its establishment. In pursuit of this commitment, we have invested in the establishment of research centres to develop legal scholarship in the selected branches of law. Human Rights Fund of Netherlands and United Nations organisations like UNDP and UNICEF have been actively supporting our research endeavours. University's Centre for Child Rights (CCR), in collaboration with UNICEF, is a testimony to this partnership. In addition, NLUO is also receiving funding from institutions viz: Insolvency and Bankruptcy Board of India and IIIPI for conducting research in commercial laws.



Beyond Academics

We promote leadership skills and the wholesome life experience of our students by encouraging them to take part in various literary, debating, cultural, entrepreneurial, and recreational activities.

In addition to imparting education and sharpening the academic skills of the students, the University is also dedicated to the overall development of the students through different initiatives. In pursuance of the same, the University has incorporated NLUO Incubation Forum - a Company incorporated under section 8 of the Companies Act, 2013. The University is in the process of starting a specialised incubation forum under the Company. The students are encouraged to undertake co-curricular activities in a perfect blend of academic rigour with co-curricular amusements so as to provide the students platforms for recreation and building long-term friendships on campus. Thus, various student run committees conduct various events to keep students healthily engaged. However, 2024 saw NLUO achieving greater heights with events, awards and inaugurations.

Informal Discussion Group

1. Guest lecture by Mr. Arun Bothra (Additional DGP, CID – Crime Branch and Transport Commissioner, Odisha) on the subject Police Investigations: Insights and Challenges

Description of the Event: The guest started the session by talking about the challenges in the police investigation. He believed that police officers, while investigating, focused more on getting the accused convicted, and they often forget that after investigation, the process is not complete and getting the right judgment from the court is necessary. The police officers often ignore the trial part of the criminal justice system, due to which sometimes innocent people get punished.

He meticulously explained the entire investigation by narrating the way in which evidence was collected and used by police to find the culprit behind the bombing.


The Sports Committee





Some of the topics which are covered are climate change litigation, climate and sustainable finance, climate migration etc. The dates for admission to this course and full details of the course are announced on the NLUO website around October every year.

National Law University Odisha's Constitutional Law Society (NLUO - CLS) is committed to providing students with a comprehensive understanding of constitutional principles and jurisprudence through a range of diverse certificate courses annually. Since its establishment, CLS has organized four distinctive courses to cater to the academic needs and interests of its participants. These courses include the "Drafting Certificate Course on Quintessence of Constitution: Public Interest and Public Policy (Supreme Court Practice and Procedure)," the "Certificate Course on Supreme Court Practice and Procedure: Writs, PILs, Appeals, and Special Leave Petitions," the "Credit Course on The Economics of Constitutionalism: Principles and Practices," and the "Certificate Course on Judicial Accountability: Structure, Reforms, and Challenges." Notably, CLS has been successful in attracting a growing number of students, with over 150 registrations in its last two courses, a testament to the high demand and effectiveness of these programs.

Online Certificate Course in Cyber Law and Cyber Security

The National Law University Odisha (NLUO), jointly with the Cyber Law University, presents "Online Certificate Course on Cyber Law and Cyber Security." The course aims to disseminate knowledge regarding the constantly evolving trends impacting cyberspace and connected paradigms. It covers a diversified arena connected to cyberspace and law. This is an online course. It includes pre-recorded video lectures, live online



classes, and live doubt-clearing sessions. The course is offered in English. The duration of the course is 2 months. The participants for admission to the course can be anyone who has passed the 12th standard or possesses similar qualifications. The course covers topics such as legal challenges in cyberspace; intermediary liability and cyber law for corporates; social media and emerging challenges; cybercrime regulation; cybercrimes in the banking sector; cybercrime investigations and cyber forensics; artificial intelligence and legal challenges; legal framework of data protection in India etc.

Scholarship

The National Law University Odisha offers scholarships to deserving and needy undergraduate students from the second year onwards, keeping in view their financial status, need and academic achievement(s). The University also makes every effort to announce scholarships offered by outside agencies that may be of interest to our students.

Earning While Learning

Earning while learning is a student aid scheme instituted by NLUO to help students tide over financial insufficiency. Under this Scheme, the University allows students to serve in the library or work on the research projects undertaken by the University from time to time in lieu of remuneration to be decided by the University.

Conversion Policy (upon Vacant Seats during the Admission Process)

If no candidate is available against the Seats reserved for Resident Students of Odisha, such Seats shall be added to the relevant Categories under the All India Quota.

The unfilled Seats reserved for Scheduled Caste candidates shall be assigned to Scheduled Tribe candidates and vice-versa. If sufficient eligible SC and ST candidates are not available to fill such Seats, they shall be assigned to All India General Category candidates in order of CLAT merit.

The vacant Seats in the Foreign Nationals category would be converted to the NRI/NRIS/OCI/PIO category and subsequently, if not filled up, would be assigned to the All India General category.
