# NOTIFICATION MODIFICATION TO THE FINAL ANSWER KEY, CLAT UG 2025

Pursuant to the order of the Hon'ble Supreme Court of India dated 07 May 2025, the final answer key for CLAT 2025 has been updated as follows: one question from the Logical Reasoning section and two questions from the Quantitative Techniques section have been withdrawn, and the answer keys for one question each in the English and Legal Reasoning sections have been revised. The highlighted questions have been revised in accordance with the Hon'ble Supreme Court's and Hon'ble Delhi High Court's orders dated 7th May, 2025 and 23 April 2025, respectively.

A detailed breakup of these modifications may be seen as follows.

### MODIFICATION TO QUESTIONS CLAT 2025 UNDERGRADUATE

In total, five questions in Logical Reasoning and two questions in Quantitative Techniques are withdrawn. Accordingly, the evaluation of candidates for the CLAT 2025 UG shall be out of 113 marks instead of the originally announced 120 marks.
