#### Vacant Seats Admission Instruction

The allocation of vacant seats shall be done strictly according to the All India Rank (AIR) merit, for the respective categories without any exceptions or deviations.

Please follow these instructions carefully to ensure a smooth application process.

- 1. All India General Category:
  - Only General candidates with an All India Rank (AIR) up to **1200** are eligible to apply. **Vacant Seat Allocation for All India General Category**
- a. One seat is available under horizontal reservation for the PWD category
- b. One seats is available under horizontal reservation for the XS-Service category
- c. One seats is available under horizontal reservation for the woman / XS-Service category
- d. One seat is available under horizontal reservation for the Women category

However, candidate of any rank can apply if eligible for horizontal eservation under XS and PWD Category.

  - iv. Maharashtra Caste Certificate and Caste validity certificate.
  - v. Non-Creamy Layer Certificate (not required for MH-ST / MH-SC / MH- EWS category).
  - vi. Application fees receipt.
- 4. Candidates are requested to pay prescribed fee of Rs. 1,000/- per application through PayTM towards application processing fees.
