APPLICATIONS ARE INVITED FOR ADMISSION TO THE VACANT SEATS IN THE B.A. LL.B. (HONS.) AND B.COM. LL.B. (HONS.) PROGRAMMES (Applications must be submitted ONLINE only) (For the Academic Year 2025-2026)

After completion of three rounds CLAT counselling a few vacant seats are available for the Academic Year 2025-2026 in the B.A. LL.B. (Hons.) and B.Com. LL.B. (Hons.) degree programmes at Tamil Nadu National Law University, Tiruchirappalli. Applications are invited from interested candidates who fulfil the eligibility criteria prescribed in this notification.

It is to be noted that the current vacancies as well as any that may arise in future will be filled only from among the candidates applying under this notification untill the conclusion of the admission process for the Academic Year 2025-2026. Only those candidates who appeared for CLAT 2025 and have secured a rank not lower than the rank mentioned against their respective categories below are eligible to apply under this notification. Example, for All India - General category, any rank between 1 and 5763 are eligible to apply, similarly the same applies to other categories also.

The candidates who have applied under above mentioned category are eligible for admission for the academic Year 2025-2026 to the B.A.LL.B. (Hons), B.Com. LL.B. (Hons). However, the candidate should have written the CLAT 2025, which was held on December 1, 2024. The admissions will be held based on CLAT-2025 Rank.

Instructions to Eminent Sports Persons Quota (Tamil Nadu Category) (ESP-TN):

Concerning the ESP-TN (Eminent Sports Person from Tamil Nadu) horizontal reservation category, the candidate shall be a resident of Tamil Nadu prior to the date of the medal-winning performance. He/She shall fulfill all eligible minimum education qualification criteria prescribed for the Tamil Nadu category and the programme applied for. Only Gold/Silver/Bronze Medals & related Sports certificates from the preceding four academic years (i.e., from June 2021 to May 2025) will be considered. However, only one highest achievement at the International or National or State level in a given academic year will be considered for selection, in that order of preference. Selection will be based on CLAT Rank and continuous performance over the preceding four academic years. Further, tournaments conducted by Federations not recognized by the official sports authority of Tamil Nadu will not be considered. Similarly any tournament conducted by associations, derecognized by the official state sports authority of Tamil Nadu will not be considered.

Instructions to TN Government School Quota (GSSQ-TN):

It is clarified that any candidate applying for vacant seats under the Government School Students Quota (GSSQ) should have studied from 6th to 12th standard in one or more Government Schools in Tamil Nadu only. Students may have studied in either Tamil or English Medium. Government Schools of Tamil Nadu means and includes all Government schools, Corporation schools, Municipal schools, Panchayat Union schools, Adi Dravidar and Tribal Welfare schools, Kallar Reclamation schools, Forest Department schools and other schools managed by Government departments.

The candidates admitted under the 7.5 percent seats on preferential basis for the Government School students are exempted from payment of all fees except refundable deposits, since the Government of Tamil Nadu will reimburse the entire fees amount except refundable deposits. In case the Government of Tamil Nadu does not sanction the fees for any reason, they may be required to remit the fees in future.

Son/Daughter of Ex-Servicemen Quota (XS-TN):

The student must be able to prove that he/she is the son/daughter of Ex-serviceman and is solely dependent on the Ex-Serviceman.

Wards of Kashmiri Migrants and Kashmiri Pandits/ Kashmiri Hindu (WKM):

The student must be ward of Kashmiri Migrants and Kashmiri Pandits/ Kashmiri Hindu.

THE CANDIDATES WHO WISH TO APPLY UNDER THE SPECIAL CATEGORY – SPECIALLY ABLED PERSONS QUOTA, EMINENT SPORTS PERSON QUOTA, GOVERNMENT SCHOOL STUDENT QUOTA, EX-SERVICEMEN QUOTA AND WARDS OF KASHMIRI MIGRANTS AND KASHMIRI PANDITS/ KASHMIRI HINDU QUOTA ARE ADVICED TO READ THE RESPECTIVE ELIGIBILITY CRITERIA CAREFULLY. YOU MAY APPLY TO THE COURSE IF YOU ARE ELIGIBLE UNDER THAT PARTICULAR CATEGORY.

Minimum Eligibility for admission to B.A. LL.B. (Hons.) and B.Com LL.B. (Hons.):

- 1. In order to seek admission to the U.G. programmes it is mandatory to have passed the 10+2 exsmination or an equivalent examination with not less than
 - a. Forty Five percent (45%) marks or its equivalent grade for candidates of all categories except SC/ST
 - b. Forty percent (40%) marks or its equivalent grade for candidates belonging to SC/ST categories
- 2. It is mandatory that the candidates should have appeared in the Common Law Admission Test (CLAT) 2025. Any candidate who has not paid the counseling fee for whatever reason and who could not participate in the CLAT counseling process may also apply to TNNLU, Tiruchirappalli against this notification.

Mode of Payment of the application processing fee:

INSTRUCTIONS TO THE APPLICANTS:

- 1. The candidates are required to note that for any vacancy which may arise in future, TNNLU will not issue any new admission notification. Only those who apply under this notification will be considered for any such future vacancies as and when they arise.
- 2. The candidates must pay the full fees upon selection under any of these categories, on or before the last date for payment of fees as specified in this notification. Similarly, any candidate who may have confirmed the admission in any other National Law University which they may have secured under any of the three lists released by the Consortium of National Law Universities cannot officially migrate to the Tamil Nadu National Law University as the exercise of revise option is over along with the third list released by the Consortium of National Law Universities. Hence, such candidates are also required to pay the full fees upon selection under any of these categories on or before the last date for payment of fees as per this notification.
- 3. Please note that all the documents which are required to be uploaded as per the notification must be uploaded without fail. The candidates are mandatorily required to disclose the marks obtained by them in the qualifying examination. And for proof of marks obtained, scanned copy of the statement of marks issued by the relevant board or the printouts of online results published and available on the official website of the relevant board must be uploaded.
- 4. Such print outs of online results will be considered only as a provisional submission and the final statement of marks or the transcript shall be submitted by way of giving undertaking. Such an undertaking should also be given for any other document which may not be available with the candidate in certain circumstances.
- Application once made to the Tamil Nadu National Law University cannot be withdrawn and under no circumstances the application processing fees of INR 1000/- (Rs.750 for SC/ST) paid will be refunded to the candidates or to anyone who may have paid such amount on behalf of the candidate.
- 6. To submit the filled in application form, the Google link will be available from **3 PM on 28.06.2025**.
- 7. The last date to fill-in the online application form through Google link is **5 PM on** 06.07.2025.

- 9. After receipt of all the applications, Merit List and Waiting List will be prepared based solely on the CLAT rank only. The same will be published on the website of TNNLU on **09.07.2025**.
- 10. Candidates who intend to apply for both B.A. LL.B. (Hons.) and B.Com. LL.B. (Hons.) need to submit separate applications.
- 11. The shortlisted candidates must pay the full fees including user charges within 3 working days, failing which the allotment will be cancelled.
