## **ABOUT UNIVERSITY,**

The Maharashtra National Law University, Chhatrapati Sambhajanagar (Aurangabad), an Institute of National repute, was established under Act No. VI of 2014 by the State Legislature of Maharashtra, to fulfill the aspiration of people of Marathwada region. # ACADEMIC PROGRAMMES

The University commenced B.A.LL.B. (Hons.) programme from the Academic Year 2017-18. The University introduced LL.M. (Master of Laws) Programme in the Academic Year 2018-2019. The University began B.B.A.LL.B. (Hons.) Programme from the Academic Year 2022-2023.

## **A) UNDER-GRADUATE PROGRAMMES IN LAW:**

### **I. B.A.LL.B. (HONS.):**

Academic Curriculum of the University for the B.A.LL.B. (Hons.), a five year Integrated Degree Programme, is inspired by the University Grants Commission's (UGC) Curriculum Development Committee Report (CDCR) and the Bar Council of India (BCI). The course curriculum imbibes the multidimensional legal approaches in consonance with trends of globalisation, pluralism and social integration. Further, clinical legal education is an integral component of the academic curriculum of the university through which students understand how to comprehend contemporary socio-legal issues to serve the society at large. The Programme curriculum promotes interdisciplinary approach of integrating Law, Social Sciences and Humanities. The University follows semester system with six working days in a week as per the norms of the University Grants Commission and the Bar Council of India, New Delhi. The University introduced Choice-Based Credit Based System (CBCS) for undergraduate degree Programme.

The students are required to earn a total of 250 credit points spread through out the Programme of five years; however the students can be allowed to earn more credits from the Programme offered by the external experts from time to time. Further, the Programme structure is designed to impart total 58 (Fifty Eight) papers out of which 48 (Forty Eight) are compulsory papers, 4 (Four) are compulsory clinical papers and 6 (Six) are optional papers.
