## ***The research opportunities present at NLU Meg are:***

**Research Fellow** – Research Fellows tackle defined research problems and assist with teaching assignments.

**Doctor of Philosophy (Ph.D.):** This is a fully funded residential program supported by various funding agencies, domicile governments, or University

**Post Doctoral Fellow** – Ph.D. graduates can continue research training after completing their doctoral studies.

**Working Fellow** - This enables professionals in academia, professions, judiciary, or industry to conduct targeted research.



# PROGRAMMES

The University follows a hybrid learning model, combining resident faculty with visiting scholars from national and international institutions. Academic programmes encourage student exchange, interdisciplinary collaboration, and research engagement during trimester breaks. Undergraduate programmes span five years, while postgraduate programmes are of two-year duration. The academic calendar follows a three-trimester system, commencing each year in July, ensuring a dynamic and flexible learning structure aligned with contemporary standards.



## HIGHLIGHTS

- Students engage in approximately 40 hours of academic activity per week.
- Each trimester lasts 12 weeks, with internships scheduled after the second and third trimesters.
- Programmes follow a choice-based credit system, comprising taught and non-taught courses.
- Credits reflect academic engagement, with one credit equivalent to eleven hours of academic work.
- Students may opt for a trimester break in the final year of undergraduate or postgraduate study.
- Courses are structured across progressive levels based on complexity and depth



# UNDERGRADUATE PROGRAMMES

NLU Meg presents students with a diverse array of three Undergraduate Degree Programmes:

1. Bachelor of Arts (Policy Science) and Bachelor of Laws (Hons) [BA LL.B (Hons)]
2. Bachelor of Business Administration and Bachelor of Laws (Hons) [BBA LL.B (Hons)]
3. Bachelor of Business Administration FinTech [BBA (FinTech)]
4. Bachelor of Science (Data Science) and Bachelor of Laws (Hons) [BS LL.B (Hons)]

To successfully fulfil the requirements of the Undergraduate degree programme, students are required to accrue the following credits over a span of five years:

- BA/BBA/BS LL.B (Hons): 280 credits
- BA/BBA/BS LL.B (Hons) with a Double Minors degree: 300 credits
- BA/BBA/BS LL.B (Hons) with Major and Minor: 320 credits
- BA/BBA/BS LL.B (Hons) with Double Majors: 340 credits

# POSTGRADUATE PROGRAMMES

## **Regular Two-Year Residential Programme:**

- Students are expected to complete a specified credit requirement over the duration.

## **For the forthcoming academic year, the following Postgraduate Programmes are available:**

- Master of Laws [LL.M (Major in Corporate Law)]
- Master of Laws [ LL.M (Major in Criminal Law)]
- Master of Science [M.S (Public Policy Analytics)]

To fulfil the requirements of the Postgraduate Programme, students are required to accumulate a minimum of 80 and a maximum of 140 credits within a two-year period.

# **ADMISSIONS 2026–27**

**(CLAT-BASED ADMISSION: TRANSITIONAL ARRANGEMENT)**

**National Law University Meghalaya** is admitted as a member of the **Consortium of National Law Universities (CNLUs)** with effect from **January 2026**. **NLU Meghalaya** will use **CLAT 2026 scores** for admissions to the **Academic Year 2026–27**.

Accordingly, for the Undergraduate and Postgraduate Programmes Academic Year **2026–27 admission cycle**, candidates shall be admitted to **NLU Meghalaya on the basis of CLAT 2026 scores through a University-managed admission and counselling process, and not through the Consortium's centralised CLAT counselling portal for this year**.

**Candidates may kindly note that:**

- **CLAT 2026 is the mandatory and valid qualifying examination** for admission to NLU Meghalaya for the Undergraduate and Postgraduate Programmes **Academic Year 2026–27**; and
- **Admissions shall be conducted directly by NLU Meghalaya**, using CLAT 2026 ranks, **outside the centralised CLAT counselling mechanism for this year only**.

# IMPORTANT INFORMATION

- **Conversion Policy:**

The National Law University Meghalaya (NLU Meg) does not convert CGPA into percentage marks for candidates whose degree-awarding institute employs the CGPA system.

The admissions process considers the CGPA awarded in the transcript.

- **Scale Discrepancies:**

In instances where the CGPA is on a scale different than 10, the University will undertake the calculation of the candidate's eligibility corresponding to the equivalent scale.

- **Eligibility for Final-Year Candidates:**

Candidates in the final year of their qualifying degree are eligible to apply for the Postgraduate programme.

- **Documentation Requirement:**

Final-year applicants for the Postgraduate programme must furnish proof of their CGPA until the last semester along with their applications.
